

Intro to Dressage Show Saturday, August 7, 2021

The day starts with a brief overview of a dressage show from the judge, followed by a Q & A session to welcome riders with questions to the show.

Riders will then ride their selected test in a Ride-Critique-Ride format of riding the test once, getting comments and feedback from the judge then riding the same test to be scored. Ride times will be assigned after closing date of August 3.

- Entry fee per test: \$30 for HCRC members, \$35 for non members.
- Entries now open and **CLOSE** August 3. Checks payable to Hampshire County Riding Club. Ride time updates posted online and sent by email by August 5.
- All participants must sign the entry form which is also a release. Participants under the age of 18 must have a parent or guardian sign the entry form.
- All participants must wear an approved ASTM/SEI helmet with chin strap at all times when mounted. Show attire should be neat and tidy, though not formal.
- Please, **NO DOGS**. Parking and porta-potty available on show grounds. Please bring food and drinks for yourself and water for your horses.
